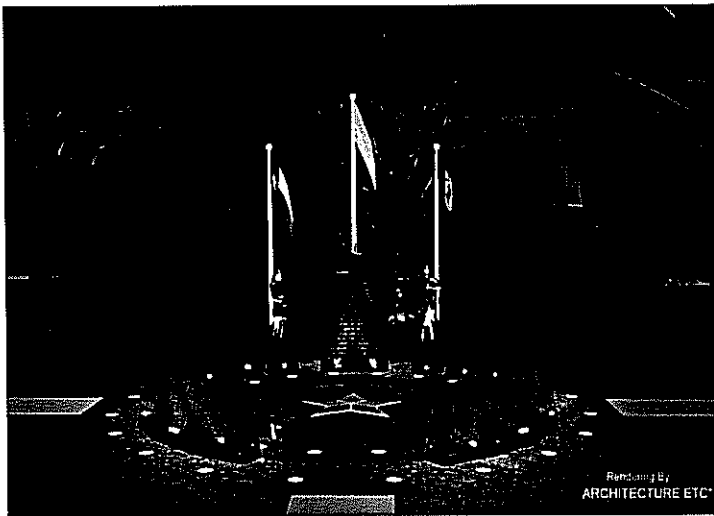

1. No marinated or pre-seasoned meat until after meat inspection (excluding fajitas). Prefer meat to be in original package. Please bring meat for inspection to Head Cook's meeting on Friday.
2. No garnishes, sauce, foil or other items permitted in meat container when submitted for judging. Containers will be provided by Cook-Off Committee.
3. Cooking area must be kept clean and sanitary.
4. No open holes or pits in ground.
5. Drip Pan for each pit. No ashes on ground.
6. Fire Extinguisher for each pit.
7. No gas or propane, wood product or charcoal ONLY.
8. All cooking must be done on site.
9. No glass bottles.
10. Excessive music will not be tolerated after 11:00 pm. 1st time will be a warning, 2nd time is subject to disqualification.
11. Each team's cooking site and/or RV site must be cleaned before you leave. Head cook is responsible for team members and guest behavior. Vulgar language and actions will not be tolerated and are subject to disqualification.
12. Decisions made by Judges will be FINAL.
